I understand that the submission of the material to you may expose the material to others and hereby specifically release 24/7 Productions, Inc. from any and all liability, direct or indirect, resulting from the improper use by any other persons or entities of any similar ideas, formats, stories, suggestions, proposals and the like relating to said material.
